### **Privacy Statement**

At Fountain of Life Center (“FLC”) through its Fitness@Lifecenter outreach, protecting the privacy and confidentiality of your personal information is important to us. Our fitness members have a right to expect that information they entrust to us will be treated with appropriate discretion and confidentiality. We are committed to maintaining your privacy and safeguarding your account, transactions and personal information.

When used in this Privacy Statement, the words “we” “our” and “us” refer to Fountain of Life Center’s Fitness Center and the terms “you” and “your” refer to our fitness center’s members and former members.

For the purposes of this statement, the following definition applies:

“Nonpublic personal information” means information about you, which is not available from public sources, obtained in connection with providing you with a fitness center membership. For example, nonpublic personal information includes information regarding your account balance, payment history and health information. It also includes your membership number, date of birth, and other information associated with you in particular through one or more identifiers.

### **Information We Collect**

As a Fitness Center, we collect, retain, and use nonpublic personal information about individual members in order to provide healthy, safe fitness services to our members. We collect nonpublic personal information about you from the following sources:

- Information we receive from you on applications and other forms
- Information about your transactions with us

### **The Confidentiality, Security, and Integrity of Your Nonpublic Information**

We restrict access to nonpublic personal information about you to those employees and volunteers who need to know that information to provide services to you. We maintain physical, electronic, and procedural safeguards that comply with federal standards to guard your nonpublic personal information.

### **Information We Disclose to Affiliated Organizations**

Unless we are directed by you in writing we may disclose the following kinds of nonpublic personal information about you to FLC’s Church office:

Your name, address, date of birth, phone number and email address.

## **Reasons for Disclosure**

Here is why we may disclose nonpublic personal information to affiliated organizations about you:

To provide our fitness members with information about Fountain of Life Center, Life Center Academy and Life Center.

## **Information We Disclose To Nonaffiliated Third Parties**

We will not disclose nonpublic personal information about you to any nonaffiliated third parties except as permitted or required by law.

## **Nonpublic Personal Information and Former Members**

We do not disclose nonpublic personal information about former members, except as permitted or required by law.

## **Information Storage**

FLC may store the information collected during your visit on an electronic database. FLC uses security measures to protect against loss, misuse and alteration of data stored in our systems.

## **You Have the Right to Direct Us to NOT DISCLOSE**

We have explained the kinds of nonpublic personal information we may disclose to our affiliates. If you prefer that we do not disclose nonpublic personal information to our affiliates, you may opt-out of those disclosures, that is, you may direct us not to make those disclosures (other than the disclosures permitted or required by law).

Federal law gives you the right to limit some, but not all, information sent from our affiliates. Federal law also requires us to give you this notice to tell you about your choice to limit information from our affiliates. You may limit our affiliates – which include but may not be limited to our church, school and life center – from marketing their services to you based on personal information that we may collect about you and share with them.

Your choice to limit marketing offers from our affiliates will apply for at least 5 years from when you tell us your choice.

If you have a family membership, an opt-out instruction given by one participant of this membership will affect all participants of the membership.

You may opt out by providing in writing name, address and phone number with an instruction to not disclose non-public information in your membership account to any of our affiliates.
